All municipalities will pay the same cost per property for base services which is estimated at \$203.00 per property; and

**Whereas** this new model was given cabinet approval on August 13, 2014 and will commence on January 1, 2015. The new model will be phased-in over five years in order to give municipalities time to adjust to any increases in their policing costs; and

**Whereas** the Province is currently responsible for policing costs associated with Unorganized Townships; and

**Whereas** the Ministry of Finance and the Ministry of Community Safety and Correctional Services will be reviewing various issues surrounding the new billing model; and

Whereas Council for the Town of Parry Sound passed Resolution 2014-218, on November 18, 2014, endorsing the resolutions passed by the Municipalities of Killarney and Bancroft requesting that the Province implement a billing method for those properties located in Unorganized Townships so that they may contribute their fair share to the overall Provincial Policing Costs;

**Now Therefore Be It Resolved That** the Town of Parry Sound hereby endorses the resolution passed by the City of Pembroke, attached as Schedule "A", making the same request to the Province to implement a billing model for those properties located in Unorganized Townships; and
