Councillor Horne asked Mr. Brown when the road line painting will be started and to provide an update on the various construction projects underway in Town. Mr. Brown replied that parking spaces, etc. line painting is being handled in-house and has started to-day. The yellow road lines are to start on Sunday and the contractor is hoping to have all that done in one day.

Mr. Brown's update on construction: Forest Street is ongoing, Wakefield and Dufferin are being prepared for a final lift of asphalt, Bowes Street paving has started to-day, the reclamation project past Forest Street is underway and it is hoped that it will be

completed tomorrow, then Isabella and Louisa Street will start. All sidewalk work has already been done.

Councillor Borneman asked Chief Thompson about the tragic fire incident last month. He wanted to know how the new vehicle performed at the scene. Chief Thompson replied that events of a week and half ago were significant in that there was a loss of life and the building burned down. The new equipment performed very well, made quick work of putting out the fire and ensured that our fire fighters were not in danger. Chief Thompson took this opportunity to point out that there were no working smoke alarms in that dwelling. Smoke alarms are required by law and batteries cannot be removed. Councillor Horn thanked Chief Thompson and the firefighters from Parry Sound and McDougall for saving the neighbourhood.

Councillor Borneman asked Ms. Middaugh for an update on Parry Sound Gardens. Ms. Middaugh updated Council about the retirement residence located by Canadore College. They report that they have had a strong response to their marketing efforts and most were from local people. They hope to have the residence open just after the long weekend in August with a show room ready for viewing in July. They have hired a General Manager and a Director of Wellness. They have been doing a lot of marketing and are very pleased with the response they've received.
