3.2 Questions of Staff

Councillor McCann asked for an update on the demolition of the building located at 19 Parry Sound Road. Chief Thompson replied that the building was destroyed by fire and he is working with the owner to ensure it is demolished as soon as possible. They have been having problems finding someone to do it.

Councillor Keith asked Chief Thompson to update the public about the school crossing guard situation at the Parry Sound Public School. Chief Thompson replied that by-law enforcement have placed a crossing guard at the corner of Isabella and Beatty Streets. Things have calmed down regarding pedestrians and cars in the area since the first day of school. By-law enforcement staff is looking at the school travel planning to look for ways to assist in the safe crossing of the students. Mr. Brown added that staff is

looking at 3 streets, Beatty, Macklaim and Isabella surrounding the school and are monitoring to determine the traffic patterns and pedestrian traffic to determine what sidewalks need to be provided.

Councillor Keith asked Mr. Brown about the new law that cars turning left or right must wait until pedestrians have reached the other side before they proceed with their turn. Is this being monitored regarding the timing of the lights? Mr. Brown responded that yes they are monitoring this and are also looking at the possibility of red light cameras, that can be moved to various intersections, for 2016/2017. Staff is checking the intersections weekly to ensure they are running appropriately.

Councillor Borneman congratulated Mr. Brown for getting clearance from CN to start the work required under the tracks at the Forest Street reconstruction. The road is now closed. When do you think it will be completed? Mr. Brown responded that the workers are doing the directional bores next week, and are moving as quickly as they can. They are doing the crossing at the CN Tracks and the water and wastewater pipes as well. Curb and gutter has been done and the road should be ready for paving in 4 to 5 weeks. Mr. Brown is cautiously optimistic that the project will be completed by the end of the year.

5. Deputations

5.1 Russell Becker, Director of Community Relations, Gardens of Parry Sound Retirement Community

Mr. Becker provided information about Gardens of Parry Sound Retirement Community which is now open. Their 70-suite Retirement Residence offers both Independent and Assisted retirement living options in a family oriented, elegant, and home-like setting. There is a grand opening slated for October 9th at 2:00 p.m. and a Public Open House scheduled for October 29 at 2:00 p.m.

5.2 Andrea McIntyre, representing the group Parry Sound for Progressive Water Management.

Ms. McIntyre provided information about the group's objectives and goals to remove fluoride from the Town of Parry Sound's drinking water system. She also provided some scientific statistic regarding the use of fluoride in municipal drinking water.

5.3 Dr. Hardy Limeback, BSc PhD DDS, Professor Emeritus and Former Head, Preventive Dentistry University of Toronto

Dr. Limeback provided information regarding his research into the detrimental effects and impact on human health of fluoride in municipal water systems.

5.4 Bob Farrow, resident

Mr. Farrow would like to congratulate Mayor and Council on the concern they have shown regarding the staff at the water treatment plant handling this toxic substance. He asked Council to please consider Parry Sound citizens' health for the future.

5.5 Heather Dawkins, non resident

Ms. Dawkins pointed out that this issue effects not just the people in Parry Sound, but everyone visiting Parry Sound. People who shop, visit restaurants and everyone from the outlying areas that visit Parry Sound are all affected by fluoride in the Town's drinking water.

5.6 Dr. Davidson Veighey, local dentist

Dr. Veighey, representing most of the dentists in Parry Sound; Dr. Lori Lahti, Dr. Robert Guthrie, Dr. Lin Raimundo and Dr. Carl Miller, who wasn't able to attend to-night, provided information regarding the many regulatory bodies that recommend continued use of fluoride in municipal water systems.

5.7 Wendy Cooper, resident

Ms. Cooper is a teacher in the community and has 6 year old son who was tested by a naturopath who concluded that her son has too high levels of lead and of arsenic in his system. Fluoride is dangerous to our health.

5.8 Conrad van der Valk congratulated council in making their decision to not remove fluoride from the Town's water based on the information provided months ago. However, he feels the public should be able to make the decision about drinking water fluoridation. He is asking for a plebiscite on the matter.

5.9 Shelley Green

Ms. Green noted that the debate about fluoride in municipal drinking water is not technically correct. It is hydrofluosilicic acid that is in our water not fluoride.

5.10 Anna Martin, resident

Ms. Martin moved to Parry Sound to research the high instances of cancer and learning disabilities in our area. It is a combination of all the contaminants in our drinking water which makes a toxic cocktail which has the impact on our endocrinal systems.

5.11 Dr. Lin Raimundo, local dentist

Dr. Raimundo felt it was good to hear all sides. There are some alternatives. However, we still need to protect the portion in Parry Sound who will get cavities and may slip through the cracks by not being able to afford dental care.
