9.1.1 OPP Billing - Court Security Costs for 2015

**Whereas** the Town of Parry Sound is in receipt of the new OPP Billing model which will see invoices split between base costs and calls for service on an approximate 60/40 split;

**And Whereas** the OPP billing methodology incorporates a per household maximum on the reduction a municipality will see in their 2015 policing costs;

**And Whereas** the Police Services Act section 137 (2) provides that the Ontario Provincial Police Force (OPP) assume responsibilities for set out in section 137 (1) for those parts of Ontario in which it has responsibility for providing police services;

**And Whereas** under the new billing model municipalities within which courts reside are being billed for court security costs;

**And Whereas** the Town of Parry Sound is now responsible for payment of the court security costs for the Provincial Courthouse located at 89 James St in Parry Sound;

**And Whereas** the court location at 89 James St in Parry Sound deals with matters of a Provincial or Family Court nature and is not responsible for Provincial Offences Act offences;

**And Whereas** the Town of Parry Sound has received a revised OPP bill with a reduction of \$91,626 in court security costs which cannot be recovered as the maximum decrease was previously met;

**And Whereas** the Province's Court Security and Prisoner Transfer Grant provides for a 50% grant of the costs to provide court security, but only represents a 25% grant on the amount billed by the OPP.

**Now Therefore Be It Resolved That** the Council for the Corporation of the Town of Parry Sound does hereby request the Province implement a billing method whereby court security costs for Provincial Courts are not included in the municipal policing bill;

And Further that the maximum per household decrease under the OPP Billing Methodology not include the impact of reductions in court security;

**And Further** that a copy of this resolution be forwarded to the Premier of Ontario, the Minister of Community Safety and Correctional Services, the Ministry of Finance, MPP Norm Miller, the Association of Municipalities of Ontario (AMO), the Federation of

Northern Ontario Municipalities (FONOM), and the Northwestern Ontario Municipal Association (NOMA) and Ontario Small Urban Municipalities (OSUM).
